1 | BACKGROUND

Beyond Zero NPC is a registered section 21 (NPO) with a 17-year-long successful track record of delivering public health systems strengthening programmes in South Africa focusing on HIV/AIDS, STI care, TB care, patient support, treatment, and prevention. The organisation has extensive international donor grant management experience, managing various grants from Children's Aids Fund (CAF), the United States President's Emergency Plan for AIDS Relief (PEPFAR), KFW, Development Bank and the U.S. Centres for Disease Control and Prevention (CDC) and the Global Fund.

South Africa is home to the largest human immunodeficiency virus (HIV) epidemic in the world, modelled at 7.2 million people living with HIV (PLHIV) (all ages) in 2017.¹ With an estimated 260,000 new infections annually, South Africa's HIV epidemic is not only the largest in the world, but also the fastest growing.² Survey data from the same year show HIV prevalence of 14% among people of all ages (up from 12.2% in 2012), and 20.6% among those aged 15-49 years (up from 18.8% in 2012).³ Women face disproportionate HIV burden throughout the life cycle, but this gender disparity is most pronounced among adolescent girls and young women (AGYW) aged 15-24 years, whose HIV prevalence is 3.3 times greater than their male peers (15.5% compared to 4.8%).

From 2010 – 2016, the Global Fund (GF) provided support to programmes addressing Orphans and Vulnerable Children and Youth. When emerging epidemiological data reflected the enormous burden of disease on AGYW, a new programme was designed and implemented from 2016-2019, that focused prevention on AGYW. The objectives of the AGYW programme (2016-2019) were aligned to the She Conquers Campaign. Process evaluations of each programme component were undertaken, and many lessons were learnt during the grant, which has informed the design of the Global Fund grant for 2019-2022.

The AGYW Programme (2019-2022) offers an age-tailored combination prevention programme for AGYW aged 15-24. The programme targets AGYW, in and out of school, but will not decline service provision to other populations who are engaged by the programme (i.e. ABYM in-school, members of the broader community).

An adolescent girl or young women will be introduced to the programme through a number of entry points from where she would be receiving services via two main service components called the Core Service and Layered Services. She would first receive the Core Service and then follow a path of layered service within the AGYW programme.

The **Core Service** will consist of three main activities namely demand creation, a risk assessment and follow-up of journey plans for each AGYW over time. The risk assessment consists of the following five actions which takes place during a private and confidential conversation between an interventionist and an AGYW:

1. Facilitated HIV risk and vulnerability assessment; TB, STI, and GBV screening
2. Offer of HIV testing
3. Offer of male and female condoms
4. HIV, TB, STI, and GBV information
5. Service Plan

The layered services are not necessarily provided in a specific order but dependent on the needs of the beneficiary. Layered services are categorised into **biomedical**, **behavioural** and **structural** services rendered in communities and safe spaces.

The Adolescent Girls and Young Women (AGYW) HIV Prevention Program was recommended by the Technical Review Panel (TRP) as a high priority activity under the Prioritized Above Allocation Request (PAAR) for the current implementation period (1 April 2019 – 31 March 2022). For AGYW, the approach is to increase the saturation within a subset of the same priority districts and sub-districts from the allocation request.

The following sub-districts were selected for this approach:

- Nelson Mandela Bay in the Eastern Cape.
- Nyandeni in the OR Tambo District, Eastern Cape.

2|SCOPE OF WORK

This request for application seeks services of an experienced service provider to deliver biomedical, behavioural and structural intervention services to out of school AGYW 15-24 years, not in any form of education, employment and training (**NEETS**). These services will be rendered in NMB C subdistrict and OR Tambo, Nyandeni in the Eastern Cape Province

Activities in these subdistricts to include:

1. Upscale the current AGYW package of services from the current **40% to 60%** saturation of AGYW, focusing on expanding coverage and enhancing retention of AGYW who are not employed and not in education or training (NEETs), targets outlined below.
2. Provide support to the National Department of Health in preparation for the Dapivirine Vaginal Ring pilot programme in the prioritized districts. This will range from **coordination of research dissemination, development of materials, and awareness and demand creation activities**.
3. **Increase engagement of Adolescent Boys and Young Men (ABYM) program initiatives** focusing on gender norms, sexual health, violence and masculinity and the provision of layered services including testing and linkage to care.
4. Adaptive leadership programme for AGYW -implementation of current leadership programmes to assert AGYW

3| REQUIREMENTS

Successful implementing agencies should have:

Technical & Staff

- Fully understands AGYW targeted population & AGYW programme, *provide evidence of recent work with targeted population.*
- Fully understands Livelihoods Approaches for young women, *provide examples of recent work commissioned, evidence base of successful implementation.*
- Be able to strengthen linkages for AGYWs to Skills Training opportunities and programme (Skills for AGYW) as per context (Urban, Peri-Urban, Rural).
- Ability to coordinate and collaborate with local SRs/SSRs (Safe Spaces) for AGYW enrolment, *provide evidence of working with organisations who are locally based.*
- Knowledge about and ability to communicate and network with relevant district stakeholders and structures such as government departments, local and district AIDS Councils, and economic empowerment Institutions; (i.e. SMME's/NYDA/YES/EPWP/SEDA/DoL/Labour/Business Networks), *provide evidence of recent Letters of Support*
- Adequate skilled and experienced staff to manage implementation of the programme areas, including procurement, monitoring and evaluation, and finance.
- Good administration and project management ability.

Finance

- Legal status recognised to work in South Africa, enabling the Organisation to perform the above-mentioned tasks.
- Demonstrated ability to deliver quality programmes at a reasonable cost – *provide examples of recent programme delivery with evidence of costs per beneficiary.*
- Appropriate internal control systems, including policies and procedures, to prevent and detect fraud or misuse of resources.
- Accounting system that can correctly record all transactions and balances by source of funds with clear references to budgets and work plans.
- Ability to monitor actual spending in comparison to budgets and work plans.
- Ability to manage disbursement of funds to AGYW and suppliers in a timely, transparent and accountable manner.
- Ability to produce timely and accurate financial reports.

Monitoring and Evaluation

- Monitoring and Evaluation (M&E) system for routine monitoring of activities/interventions.
- Mechanisms and tools to collect and analyse data, and report on programme performance.
- Ability to produce timely and accurate programmatic reports.

5| EVALUATION CRITERIA

Evaluation Criteria for Proposals

The evaluation of submissions will be managed by a Procurement Review Committee (PRC) which will prepare a shortlist of applicants that meet the threshold for appointment. BEYOND ZERO will use the shortlist drawn by the PRC to recommend applicants to be appointed.

The evaluation process will be conducted according to the following stages:

- Stage 1: Assessment of administrative compliance with pre-qualification/eligibility criteria. Applications that do not comply will not be evaluated further.
- Stage 2: Assessment of technical competency focusing on the ability to fulfil the required scope of work.

Bidders obtaining a minimum of at least 60 out of 70 points of the technical competency requirements will be evaluated further on Price & BBEE. Selection will be done by a PRC.

- Stage 3: On-site visit to service provider(s) to clarify details about the applicant.

For applicants that satisfy the pre-qualification criteria and the administrative requirements, the weighting of the overall score is as follows:
